Call to Order

Margo welcomed BCTV President Terence Elton and Chip Marsh from the strategic planning group.

Terence welcomed everyone to the meeting. He expressed the hope that we will soon be able to have an in-person meeting at the BCTV studio.

Chip discussed the BCTV strategic plan which has been in the planning process for approximately two years. Research was done via surveys to the community, anecdotal information and a focus group. Discoveries included the need for a mission statement and a look at priorities. The pandemic did put some things on hold but meetings continued remotely. Three strategic themes were identified: outreach, sustainability and technology. Statements were refined and action steps were created based on several guiding factors such as needing to be a more integral part of the community, concerns about the FCC decision and cord cutting, and pursue alternatives to cable to engage audiences and community.

Five goals were identified: (1) Integrating BCTV into the community, (2) generating additional revenue, (3) desire to increase first run new content programming, (4) ability to increase responsible utilization of the resources used by the community,(5) ensure that it is a great place to work for employees and volunteers with up to date technology. Board will vote on the plan soon and begin to implement it over a three-year period.

Chip read the mission statements at the request of Terence.

Discussion followed. David indicated GCTV is preparing to begin a similar process and suggested each station consider doing something similar to what BCTV has done.

Discussion followed around community outreach and student involvement.

#### **Report from Matt Skane**

Matt updated some pending matters.

1. *Comcast Lift Zone* – Comcast is increasing opportunity for students by building a continuum of connectivity for them. It is an expansion and beefing up of public WiFi for

students who cannot access internet at home. The effort involves partnering with a non-profit where their site is wired for stronger access at no cost to them.

- 2. *Xfinity Watch-a-thon*: allows viewers, Comcast and non-Comcast members, to test out and watch popular programs on Xfinity for free.
- 3. *Verify Caller-Id Feature*: This feature helps protect businesses and residential customers from having to deal with robocalls. Customers should see the letter "V" in front of the Caller ID number.

Laura asked if there was any thought to allowing subscribers to remove items like sports from a package. Discussion followed. Matt will look into options but explained that there are certain parameters that must be followed when putting packages together.
